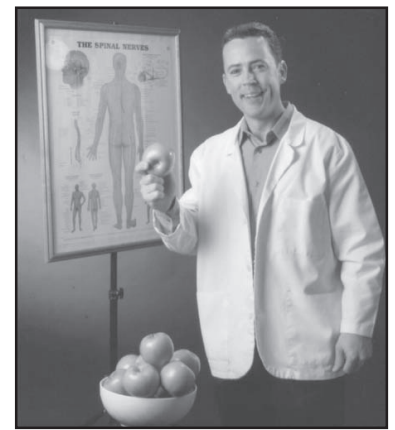
Q: Is there an age group of people that you especially like to treat?

Q: Why did consumers overwhelmingly choose Chiropractic care as their #1 source of relief?

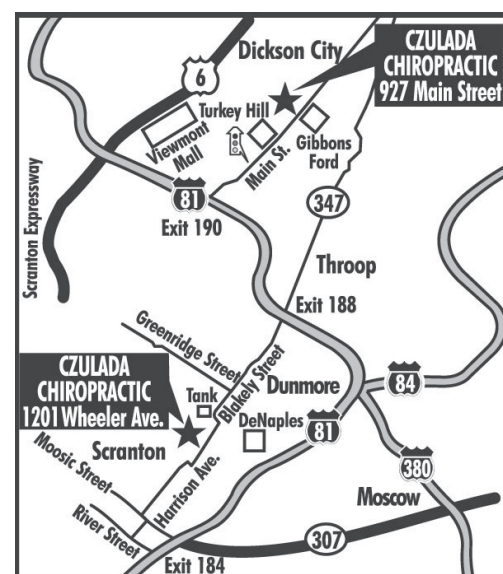
